Chief informed the board that he would like to brick off the entrance door to the alley (never used) and make that area a storage closet. Board has no objections.

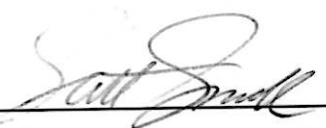

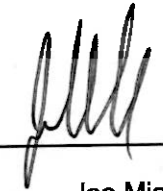
